Coupon Redemption Policy
Updated 8/11/2010

This Coupon Redemption Policy and the legal copy on Little Busy Bodies, Inc. coupons state the only terms and conditions under which Little Busy Bodies, Inc will reimburse its customer for coupon submissions ("Policy"). Your acceptance and redemption of coupons for Little Busy Bodies, Inc. products constitutes your acceptance of and binding agreement with all the terms and conditions in this policy.

Proper store redemption of our coupon authorizes you to 1. Act as our agent solely for the purpose of coupon redemption and to 2. Submit such redeemed coupons for reimbursement by Little Busy Bodies Inc. It is the retailer's responsibility to ensure its employees are aware of and in compliance with this policy. The requirements for proper coupon redemption are as follows:

- 1. U.S. Coupons are redeemable only in the Country for which they were purchased.*
- 2. Coupons are redeemable only when consumers purchase the brands, sizes and quantities indicated on the coupon, prior to the expiration date.*
- 3. Retailers must submit coupons for reimbursement within 60 days after the expiration date of the coupon.*
- 4. Consumer must pay any and all applicable taxes. Coupon cash value 1/100 cent.*
- 5. Only one coupon may be accepted by the retailer per Little Busy Bodies, Inc product purchased, as stated on coupon.*
- 6. Coupons cannot be sold transferred, duplicated or doubled. No cash value.*
- 7. For each properly redeemed coupon, retailers will be reimbursed for the face value plus \$.08 handling fee per coupon as stated on each Little Busy Bodies, Inc. coupon.*
- 8. Little Busy Bodies, Inc. reserves the right to deny reimbursement, retain and declare void any coupons presented for redemption when the following conditions occur: coupon values are altered, or retailer has insufficient stock to cover the number and types of coupons submitted.*
- 9. Coupon payments may not be deducted from payments of Little Busy Bodies, Inc. product invoices.*
- 10. Any inconsistent use of this Policy constitutes fraud and in addition to other legal remedies at the option of Little Busy Bodies, Inc. void all coupons submitted for reimbursement and coupons may be retained by Little Busy Bodies Inc. without payment.*
- 11. Little Busy Bodies, Inc. reserves the right, in its sole discretion, and without prior notice to any party, to modify, revise or eliminate any of the provisions of this policy. It is the retailer's responsibility to obtain updated copies of this policy.*
